THIS ANNEX IS ISSUED AS PART OF THE CERTIFICATE OF AIRWORTHINESS IDENTIFIED BELOW AND MUST BE ATTACHED TO THAT CERTIFICATE AT ALL TIMES.

Certificate of Airworthiness Number **ATA/8304-X01** is subject to the following conditions: **Operating Limitations:**

- The aircraft is to be operated within the limitations expressed in the **Pipistrel D.o.o Ajdovscina** flight manual for the **Pipistrel ALPHA Trainer** as amended and the operating limitations contained in CAR 262APA
- Maintenance of the aircraft must be in accordance with the approved maintenance schedule for the the **Pipistrel D.o.o Ajdovscina ALPHA Trainer** specified in the **Pipistrel ASTM-LSA-MM-All** maintenance manual, Rev.01 initial issue 25/10/10 and later approved revisions.
- This aircraft is to be operated by day under **Visual Flight Rules only**.
- This aircraft may only be operated for the purpose specified at 4 of the Special Certificate of Airworthiness number **ATA/8304-X01** dated **12th March 2013**
- If the aircraft no longer complies with one or more of these conditions, the CofA becomes void. Continued operation with an invalid CofA is a criminal offence. It is permissible, however, for the registration holder of a non-compliant aircraft to apply for an Experimental Certificate.
- Hours flown and maintenance carried out on the aircraft shall be recorded on a "**Maintenance Record Form**" produced by Recreational Aviation Australia Inc.
