12. If the aircraft no longer complies with one or more of these conditions, the C of A becomes void. Continued operation with an invalid C of A is a criminal offence. It is permissible, however, for the registration holder of a non-compliant aircraft to apply for an Experimental Certificate.
13. Hours flown and maintenance carried out on the aircraft shall be recorded on a "Maintenance Record Form" produced by Recreational Aviation Australia.
